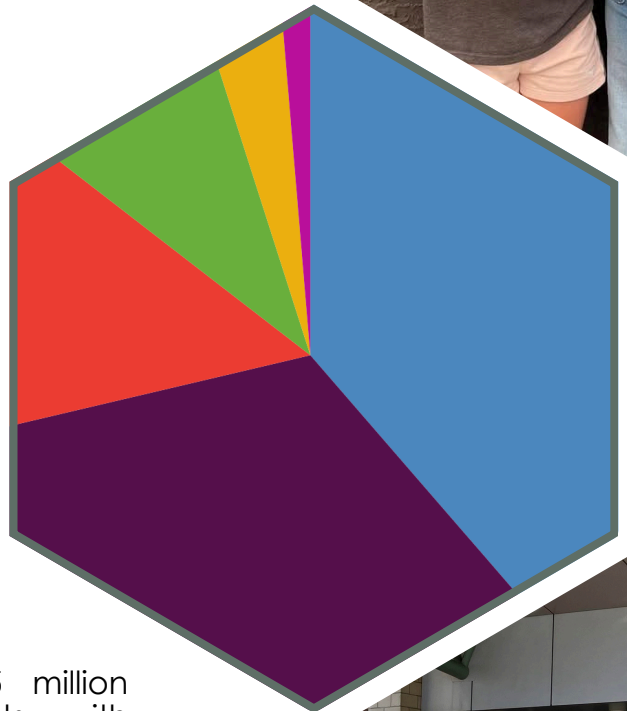

Determining Equipment Needs

Alberta Health Services allocates about \$5 million annually for urgent equipment replacements, with Foundations often being the primary funding resource for replacement of broken equipment or for innovative equipment.

Equipment needs are identified through an annual vetting process involving managers and physicians who create a list that is costed and prioritized by Senior Leadership at Red Deer Hospital and the Central Zone. Formal requests are then made to the Foundation, which, along with the board, reviews and vets them to ensure proper stewardship of donor funds.



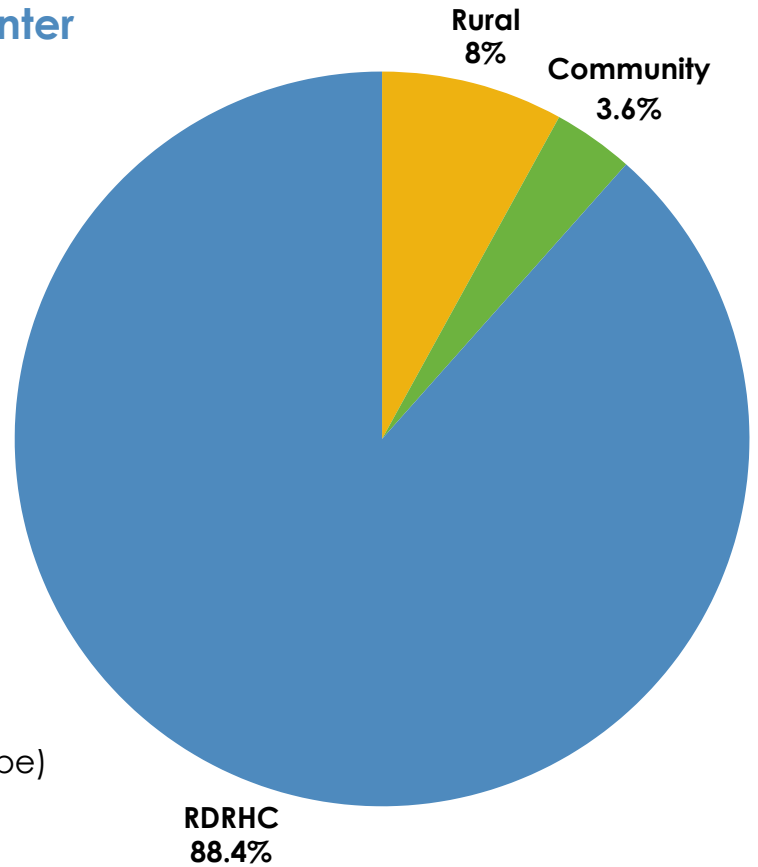

A small selection & their outcomes - made possible by donors like you

Supporting Our Smallest Patients – Enteral Feeding Pumps for the NICU

Thanks to the generosity of three kind donors, 12 new enteral feeding pumps were added to the Neonatal Intensive Care Unit at Red Deer Regional Hospital Centre. These pumps are now used exclusively for feeding vulnerable newborns who are unable to breastfeed or bottle feed. In the past, the same pumps were used for both feeding and medication, increasing the risk of error. Now, approximately 50 infants each month receive safe, accurate nutrition support. With the previous pumps being phased out by the vendor in 2024, this upgrade came just in time to ensure continuity of care for the babies who need it most.



Faster Results, Better Care - A Second Centrifuge in the Microbiology Lab

A thoughtful gift from a donor close to our hearts allowed the hospital laboratory to add a second microbiology centrifuge. Previously, only one centrifuge was used to process over 100,000 blood cultures each year, drawn from more than 2,500 patients. This critical piece of equipment has significantly improved turnaround times and helped the lab manage increasing demand. When every minute counts, faster results mean better treatment decisions and better outcomes.



Advancing Cancer Surgery - Lymphatic Mapping Probes for the OR

The family of Ronald Faye made a meaningful contribution to surgical care through a donation including five new lymphatic mapping probes. These tools are essential in breast cancer surgeries to locate lymph nodes and determine whether cancer has spread, guiding the course of treatment. The new probes also reduce the risk of infection by improving how the equipment integrates with surgical drapes. Nearly 500 patients each year will benefit from more precise, safer surgeries thanks to this gift.



Room to Move - Children's Rehab Expansion

Through the generosity of the Durham family and others, an underused meeting space in the Children's Rehabilitation Centre was transformed into a second gross motor therapy room: the Donna & Ron Durham Movement Lab. Previously, five physical therapists and therapy assistants shared a single room. This renovation has expanded therapy capacity, allowing the department to better serve the 300 children and 2,000 appointments it sees each month. It's a meaningful investment in helping young patients gain strength, coordination, and confidence.



Therapeutic Play in Long-Term Care – Tovertafel Console for Unit 35

In Unit 35, which cares for patients with extended stays of up to three months, a new cognitive therapy console has become a central part of daily life. Installed in the main dining area and funded by a group of generous donors, the Tovertafel provides interactive light-based games designed to stimulate movement, memory, and engagement. This innovative tool is helping patients maintain cognitive function and improve their quality of life during recovery.



Warmth and Comfort - Blanket Warmer for Stettler Acute Care

With the help of funds raised through staff 50/50 contributions, Stettler Acute Care replaced a malfunctioning blanket warmer - an essential part of patient comfort and care. Warm blankets help reduce anxiety, calm nerves, and improve overall well-being, often complementing pharmaceutical interventions. Approximately 12,000 to 15,000 patients annually benefit from this simple yet impactful tool. This purchase reflects the compassion and dedication of staff who care deeply about patient experience.



Cardiac Catheterization 5 years ahead of schedule

This past year has been nothing short of transformational for healthcare in Central Alberta, and your Foundation was proud to be at the center of it. In 24/25, Red Deer Regional Health Foundation is bringing forward a long-awaited, life-saving initiative: the fast-tracked launch of a Cardiac Catheterization Lab at Red Deer Regional Hospital Centre.

This is not only a major leap forward in cardiac care, but a bold and proactive step that will change and save lives. Currently, patients experiencing serious cardiac events in our region have to be transferred to Calgary or Edmonton, costing precious time. Thanks to a new retrofitted space within our own hospital, that care will be able to happen at home in the near future.

This advancement will be made possible by the Foundation's commitment to act urgently, and given an unprecedented boost through a \$10 million gift from Joan Donald, John and Heather Donald, and Peter and Kathy Lacey.

Their extraordinary generosity - the largest in our Foundation's history - is more than a donation; it's a legacy of leadership and compassion. It's estimated that the interim lab will save up to 160 lives over five years, while also helping to recruit and retain the skilled specialists our region needs.



In another extraordinary showcase of commitment to community, the Red Deer Regional Health Foundation was humbled to receive a legacy defining gift of \$869,139 from the estate of Donald and Alice Beamish.

“Alice was a long-time supporter of the Red Deer Regional Health Foundation. She knew how much they needed support,” said her niece, Debora Rice-Salomons. She shared the family's pride in seeing Alice and Donald's legacy help bring to life new possibilities for the hospital, including the expansion and arrival of the cardiac catheterization lab.

When the permanent cardiac catheterization lab opens as part of the hospital redevelopment, this interim space will evolve into a cutting-edge Vascular and Neurology Lab, creating a lasting ripple effect for patients in Central Alberta for decades to come.

As Manon Therriault, our CEO, put it: “In cardiac care, time is muscle. Thanks to the bold action of our Foundation team, our donors, and our partners at AHS, we are no longer waiting to make a difference. We are leading the way, and this year, we proved what's possible when a community comes together to meet a critical need with urgency, generosity, and purpose.

We're proud to serve as the bridge that brings the support of our donors to the greatest needs of the community.

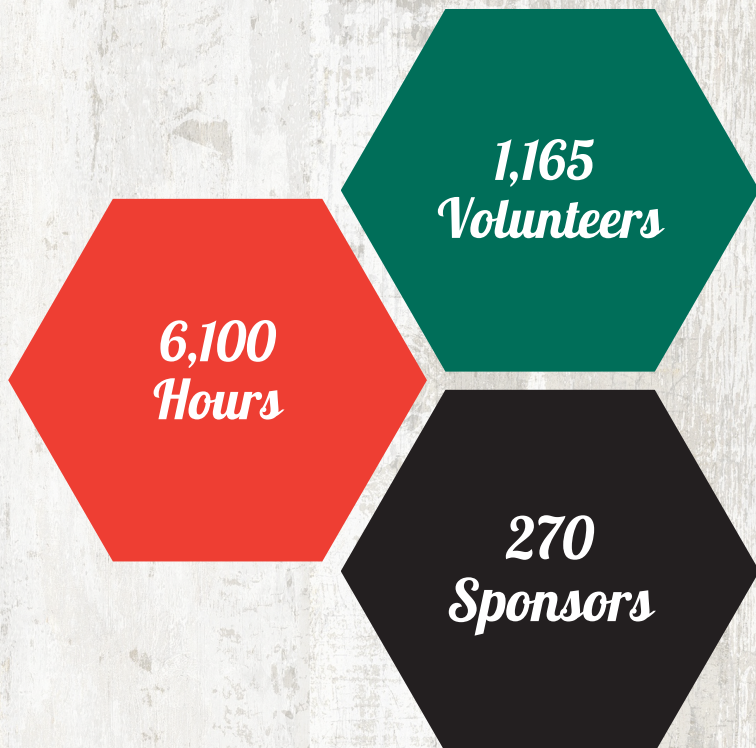


Festival of Trees

Giving the gift of time

As part of the much-needed expansion of Red Deer Regional Hospital, the 2024 edition of Red Deer's most cherished holiday event, Festival of Trees, was committed to enhancing cardiac care for our community with new cutting edge equipment.

1,165 volunteers gave a collective 6,100 hours of their time to make the 2024 Red Deer Festival of Trees a success.



Red Deer Hospital Lottery

26 years of community impact

In 2024, the Red Deer Hospital Lottery revitalized its prize strategy to boost ticket sales, adding a highly appealing blend of cash and high-value secondary prizes to the prize lineup.

Our approach included not only the traditional dream-home grand prize but also elevated the excitement by funding critical hospital equipment directly.

The new Ultrasound Robotic Headframe (\$168,000) for Unit 33 empowers clinicians to perform ultra-precise imaging with robotic-assisted positioning, reducing patient discomfort and improving diagnostic accuracy. In Endoscopy, two advanced Duodenoscopes (\$112,500) were purchased, enabling safe and detailed visualization of the digestive tract.

The Operating Room received a cutting-edge Orthopedic Implant Extraction Set (\$29,500), which allows surgeons to safely remove implants with minimal tissue disruption and faster patient recovery.

The winner of the grand prize dream home in Evergreen is Maxine Rumohr of Sylvan Lake.

The winner of the Tree Hugger Tiny Home is Mary Vincent of Red Deer.

Finally, the winner of the Mega Bucks 50, taking home \$303,600, is Carolyn Pelerine of Cochrane.



Our upcoming Capital Campaign

4 Years & 40 Million Dollars

As we turn the page into a new fiscal year, part of our attention begins to shift towards our largest - ever fundraising mission:

The \$40 million dollar “Our Legacy” campaign.

Featuring three intertwined fundraising pillars with purposeful fundraising goals, Our Legacy represents years of listening & engaging with our community - both inside and outside of the hospital. We've seen your needs, we've heard your needs, and we're taking action to meet them.

Cardiac Catheterization:

The Cardiac Health pillar focuses on building an interim cardiac catheterization lab at Red Deer Regional Hospital Centre, 5 years ahead of schedule. This will bring life-saving care to our community now, eliminating the waiting for a permanent facility is completed.

Advanced Equipment:

The Advanced Equipment pillar is focused on the purchase of technology and equipment such as a Da Vinci Surgical System, which will allow surgeons to perform complex, minimally invasive surgical procedures with precision and accuracy, and a new MRI Imaging System which speed up wait times for MRI's in our area.

Retention, Recruitment, Education

The third pillar of our campaign is dedicated to keeping the skilled healthcare professionals we have and attracting the new talent our community urgently needs. Red Deer already faces a shortage of physicians and healthcare workers - a gap that will only widen with the hospital's expansion. If we do not address these issues, burnout will drive more departures, recruitment will falter, and patients will face longer waits, fewer local options, and more trips out of town for care.

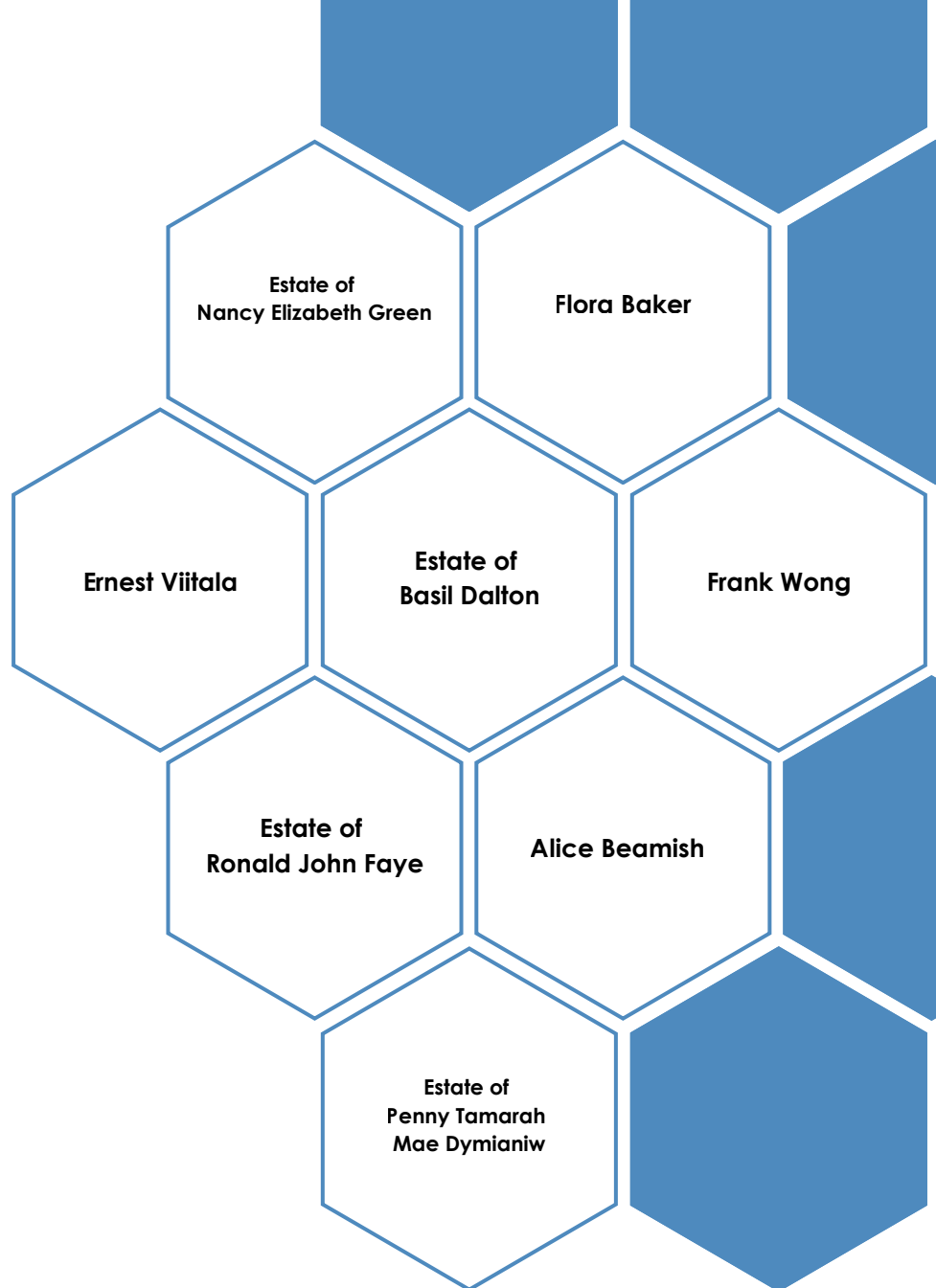

Honoring Legacy Giving

Long Term Hospital Goals

We're building forward, together. The Red Deer Regional Hospital Centre (RDRHC) Redevelopment Project is a landmark \$1.8-billion investment from the Alberta Government designed to expand capacity, modernize services, and transform care for our community.

Key developments include a new patient tower with 200 additional beds, six new operating rooms, and two cardiac catheterization labs, alongside an expanded Medical Device Reprocessing Department. A new ambulatory building (located across 39th Street from the parkade) will offer outpatient services, addiction and mental health care, renal dialysis, and underground parking.

Renovations and upgrades throughout the existing hospital will ensure services continue to evolve to meet growing needs. As construction progresses, programs, services, and equipment will be relocated within the site to support seamless care. The patient tower and ambulatory building will open ahead of the full redevelopment, which is set for completion and commissioning by 2031.

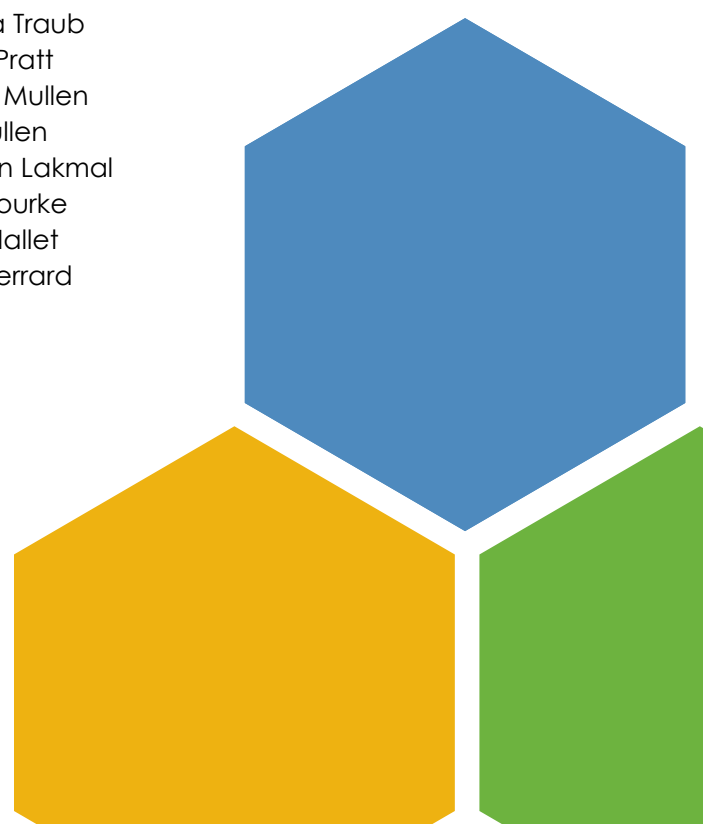
